Appliance Recycling	Online scheduling tool	Launching online scheduling tool for curbside pick-up and recycling services only starting July 1, 2020. Customers will receive \$55 incentive per unit when the online scheduling tool is used.	\$55 per unit when online scheduling tool used	Encourages customers to use the new online scheduling tool, instead of calling, and assists in reducing administrative costs long-term.
Residential Equipment	All electric prescriptive rebates	Increase electric rebates by 50% (not to exceed 70% of project cost) for measures installed July 1, 2020 to December 31, 2020. Applications must be received by December 31, 2020. Measures included are central air conditioners, smart thermostats, air-source heat pumps.	See residential applications for details	Provides stimulus offering to residential customers to participate in the prescriptive rebates program in the remaining months of 2020.

Nonresidential Equipment	All electric and natural gas prescriptive rebates	Increase electric and natural gas rebates by 50% (not to exceed 70% of project cost) for measures installed July 1, 2020 to December 31, 2020. Applications must be received by December 31, 2020. Measures included are central air conditioners, LED lighting measures, natural gas furnaces and boilers.	See nonresidential applications for details	Provides stimulus offering to nonresidential customers to participate in the prescriptive rebates program in the remaining months of 2020.
Income Qualified Multifamily IOWA ONLY	Follow-up project incentives	Increase the incentive for cost-effective follow-up projects from 40% to 70% of project cost.	Cost-effective projects incentives are 70% of project cost; non-cost-effective projects remain at 5 times the energy savings.	Assists in enhancing the overall performance of the 2020 portfolio.
Nonresidential Energy Solutions	Custom projects	Custom rebates may not reduce the simple payback for the project to fewer than 18 months instead of two years. This applies to any project preapproved from March 16 to December 1, 2020.	No change to custom rebate incentive	Provides stimulus offering to nonresidential customers to install cost-effective custom equipment by changing the simple payback restriction from no less than two years to no less than 18 months.
Nonresidential Energy Solutions IOWA ONLY	Custom project cap and customer incentive cap	Lifting the \$100,000 custom project cap and the \$250,000 customer incentive cap for projects preapproved or installed on or before 12/01/2020. All completed/preapproved project's paperwork must be submitted by 12/01/2020.	N/A	Assists in enhancing the overall performance of the 2020 portfolio.
Nonresidential Energy Solutions	Small Business Express	After first SBX capital project is completed, provide additional 30% electric or natural gas rebate (based on January 1, 2020 SBX rebates and not to exceed 70% of project cost) for measures installed July 1, 2020 to December 31, 2020. Final project documentation must be received by December 31, 2020.	See Small Business Express Measure list for details	Provides stimulus offering to nonresidential customers to participate in the Small Business Express offering in the remaining months of 2020.
